PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Thursday June 3, 2021 at approximately 0047 hours I was dispatched to the intersection of Lake Worth Road and 120th Avenue, in the Village of Wellington, regarding a traffic stop with a possible impaired driver. Upon arrival I met with D/S K. Sheehan # 7952 who provided me with a supplemental probable cause affidavit stating: "I was conducting speed enforcement in the 12000 blk of Lake Worth Road. I was monitoring eastbound traffic when I observed a vehicle traveling at a high rate of speed and above the posted speed limit of 40 MPH. I activated my in car radar and received a lead tone and a reading of 67 mph radar stalker dual SN #IR078019. I pulled out behind the vehicle, which continued eastbound and was bearing Florida tag "NCYU56". The vehicle continued to travel around 60mph. I activated my emergency lights to conduct a traffic stop on the truck at Lake Worth Rd. and 120th Ave. The vehicle pulled over to the right. I made contact with the driver who identified himself by his Florida driver's license as Robert J Sorensen 08/12/1971. While speaking with Sorensen I observed he had blood shot glassy eyes, slurred speech and the smell of an unknown alcoholic beverage emitting from his person. I asked Mr. Sorensen where he was coming from and he replied the airport but then stated he had just dropped his son off there and he came to Wellington to see some friends. I asked Mr. Sorensen if had anything to drink and he stated a couple beers."

Upon my arrival I approached the defendant's vehicle on the driver side. The defendant was occupying the front driver seat and was the sole occupant. I informed the defendant why I was here and asked him to exit his vehicle. The defendant was cooperative and exited the truck. The defendant stated that he had several beers at a friends house in Wellington. He then informed me that he did not have any other impairment.

OBSERVATION OF DRIVER:

The defendant had a noticeable orbital sway as he stood. The defendant's clothing was neat and properly worn. The defendant weaved as he walked from their vehicle to the front of mine. The defendant's eyes were red, glassy and bloodshot. The defendant's speech was slow and slurred. The defendant would have difficulty maintaining balance any time I asked him to put his feet together.

DRIVER'S STATEMENTS:

The defendant admitted drinking several beers.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage coming from the defendants breath, which intensified when the defendant spoke.

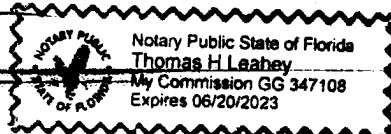

The defendant missed heel to toe. The defendant performed an improper turn. The defendant did not count aloud. The defendant used his arms for balance. The defendant stopped walking and said "turn?" The defendant had a noticeable orbital sway during this task.

ONE LEG STAND:

The defendant was placed into the instructional stance for the One Leg Stand. The defendant was instructed to not move from the instructional position until told to do so. The defendant was given instructions and a demonstration. The defendant stepped from the instructional stance prior to being told to do so. The defendant put his foot down. The defendant did not keep both legs straight. The defendant used his arms for balance. The defendant would start counting at one again rather than continuing from where he left off as he was instructed. The defendant had a noticeable orbital sway during this task.

FINGER TO NOSE:

The defendant was placed into the instructional stance for the Finger to Nose. The defendant was instructed to not move from the instructional position until told to do so. The defendant was given instructions and a demonstration. The defendant had to be reminded to keep his feet together. The defendant did not touch tip to tip as instructed. The defendant had a noticeable orbital sway during this task.

ROMBERG ALPHABET:

The defendant was placed into the instructional stance for the Romberg Alphabet. The defendant was instructed to not move from the instructional position until told to do so. The defendant was given instructions and a demonstration. The defendant had to be reminded to keep their feet together. The defendant correctly recited the alphabet. The defendant had a noticeable orbital sway during this task.

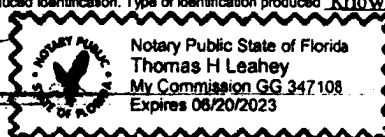

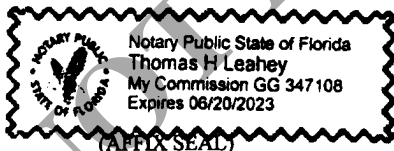
