THEN AND THERE DRIVE A VEHICLE, TO-WIT: A 2014 NISSAN FRONTIER, BEARING FLORIDA REGISTRATION NUMBER DCD-J96, WHICH WAS INVOLVED IN A CRASH INVOLVING PERSONAL INJURY TO DARCY LEE HUNT, AND THE SAID DEFENDANT DID WILLFULLY FAIL TO STOP SAID VEHICLE AT THE SCENE OF THE CRASH UNTIL HE HAD FULFILLED THE REQUIREMENTS OF F.S.S. 316.062, TO-WIT: DID NOT GIVE HIS NAME AND ADDRESS AND THE REGISTRATION NUMBER OF THE VEHICLE HE WAS DRIVING AND DID NOT RENDER REASONABLE ASSISTANCE TO PERSONS INJURED IN THE CRASH.

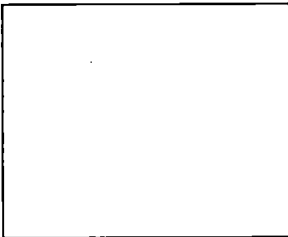
