Before me this date personally appeared WILLIAMS, COREY (3408) who being first duly sworn deposes and says that on 4 day of May (year) 2017 at 2148 POLK ST, HOLLYWOOD, FL 33020 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

INFLUENCE OF AN ALCOHOLIC BEVERAGE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED, UPON ARRIVING AT THE B A T FACILITY AT THE HOLLYWOOD POLICE DEPARTMENT, THE ARRESTEE REFUSED TO PROVIDE A BREATH SAMPLE

ON THE ABOVE DATE AND TIME, WHILE ON ROUTINE PATROL, I OBSERVED A BLUE CHEVY TRUCK DRIVING AGAINST TRAFFIC ON THE 2300 BLOCK OF POLK ST WHICH IS A ONE WAY ROAD I IMMEDIATELY ACTIVATED MY EMERGENCY LIGHTS AND SIRENS TO STOP THE VEHICLE BUT THE ARRESTEE WAVED HIS ARM OUT OF THE WINDOW AND CONTINUED TO DRIVE EASTBOUND AGAINST TRAFFIC ON POLK ST I FOLLOWED THE VEHICLE AND CONDUCTED A TRAFFIC STOP AT 2148 POLK ST UPON MAKING CONTACT WITH THE ARRESTEE WHO WAS THE SOLE OCCUPANT OF THE VEHICLE AND WAS SEATED IN THE DRIVER'S SEAT OF HIS VEHICLE I OBSERVED THE ARRESTEE WITH WATERY, RED BLOODSHOT EYES, AND UPON INSTRUCTING HIM TO EXIT HIS VEHICLE, I SMELLED THE AROMA OF AN ALCOHOLIC BEVERAGE EXUDING FROM HIS BREATH HE ALSO HAD SLURRED SPEECH, AND DIFFICULTY FOLLOWING BASIC INSTRUCTIONS BASED ON MY KNOWLEDGEING TRAINING AND EXPERIENCE, MR BATTISTA DISPLAYED OBVIOUS SIGNS OF IMPAIRMENT FOR MY SAFETY, AND THE SAFETY OF PERSONS AND PROPERTY IN THE AREA, I ASKED MY BATTISTA TO STEP OUT OF HIS VEHICLE UPON EXITING HIS VEHICLE, HE WAS SWAYING IN ALL DIRECTIONS

THE ARRESTEE STATED THAT HE LEFT HIS PLACE OF EMPLOYMENT 830 S DIXIE HWY AND WAS DRIVING TO 2000 HOLLYWOOD BLVD IT SHOULD BE NOTED THAT THE 2300 BLOCK OF POLK STREET IS NORTH OF HIS INTENDED DESTINATION
