The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a blue 2019 Mercedes 4-door (FL TAG #HVHZ69) eastbound on Platt St W, leaving the Hyde Park Café. Once the vehicle began to accelerate from the parked position in front of the nightclub, it lost traction on its tires and accelerated rapidly, causing a small "burnout" and continuing at a high rate of speed. As I followed behind the vehicle, I observed it to drift back and forth, crossing over the lane divider lines on both sides and leaving its lane several times. During the traffic stop for false start and the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several indicators of impairment, to include: watery/bloodshot eyes, blank/dazed stare, slurred speech, fumbling fingers, slow deliberate movements, uncoordinated movements, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he provided 2 valid breath samples, measuring .070/.071 BrAC.
