The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 11/21/2019, at approximately 0248 hours, I responded to the intersection of Apollo Beach Bl. and 41 Hw. N. Apollo Beach, FL. 33572 to assist Deputy Berg(ABN:257679) with a traffic stop. Deputy Berg conducted the traffic stop due to the vehicle failing to maintain a lane. When he made contact with the defendant, who was the only person in the vehicle and in the driver's seat, he observed indicators of impairment. When I arrived on scene, I made contact with the defendant and observed indicators of impairment. The defendant elected to performing the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide a lawful breath sample after implied consent was read. The defendant was identified via Florida Driver's License.
