## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

The following occurred in the City of Delray Beach, County of Palm Beach, FL.  
On 02/20/21 at 0210hrs Ofc. Steed #944 DBPD was conducting traffic enforcement in the 1200 block of N. Federal Hwy. Ofc. Steed observed a black 2017 GMC Sierra pickup traveling north. Ofc. Steed used his department issued speed laser and received a measurement of 52mph in a posted 35mph speed zone. Ofc. Steed conducted a traffic stop by activating his emergency lights of his marked Delray Beach Police patrol vehicle. The GMC stopped in the parking lot at 1733 N. Federal Hwy. (Sandes Restaurant). Ofc. Steed met with the white male driver and identified him by his GA DL as Robert Patrick Copenhaver III. Copenhaver III was sitting in the driver seat and was the only person inside the GMC at the time of the stop. The GMC's engine was running and the vehicle key was in the ignition. Ofc. Steed did not lose sight of the GMC from the traffic violation location to the location of the traffic stop. I responded to the traffic stop scene to conduct a DUI investigation. I met with Copenhaver III who was sitting in the GMC's driver seat. I also identified Copenhaver III by his GA DL.

## OBSERVATION OF DRIVER:

Copenhaver III had an odor of an unknown alcoholic beverage coming from his person. Copenhaver III's eyes were red and had a glassy appearance. Copenhaver III's pupils were slow to react to changes in light. Copenhaver III's speech was slurred while he was speaking. Copenhaver III went through mood swings and became emotional on scene. Copenhaver III requested to exit the GMC and after exiting, Copenhaver III was unsteady on his feet. Copenhaver III swayed while standing still.

## DRIVER'S STATEMENTS:

Copenhaver III stated he was on his way home when he was stopped by the police. Copenhaver III stated he was at a bar on "Atlantic Ave." prior to driving home. Copenhaver III initially stated he consumed one beer at the bar but would not describe what kind of beer it was (i.e. can, bottle or draft). Copenhaver III later admitted to consuming "a few beers". I asked Copenhaver III how many "a few" was and he replied he did not know. Copenhaver III stated during roadsides he knew he shouldn't have driven the GMC. Copenhaver III requested to leave the GMC in the parking and he would walk home. Copenhaver III stated his life was ruined and he just got a decent job in the area. Copenhaver III stated he was at the bar with his new boss and was worried he will be fired.

Copenhaver III had an odor of an unknown alcoholic beverage coming from his person.

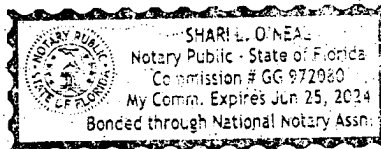

Other Observations:

Copenhaver III stated his left eye was a glass eye. His left eye was the same shade of red as his right eye. His left eye moved side to side and up and down while following the stimulus light. Copenhaver III swayed while standing still. Copenhaver III did not keep his feet together as instructed during the HGN/VGN roadside.

WALK & TURN:

Copenhaver III swayed while standing still. Copenhaver III did not remain in the instructional phase position as instructed. Copenhaver III started walking with the wrong foot and did not touch heel to toe on several steps. Copenhaver III did not keep his arms to his side as instructed and used his arms for balance. Copenhaver III stepped off the line on each series of steps.

ONE LEG STAND:

Copenhaver III swayed while standing still. Copenhaver III did not raise his foot off the ground 6 inches as instructed and put his foot down on the ground several times. Copenhaver III had to be instructed to continue after putting his foot down on the ground. Copenhaver III did not keep his arms down at his side.

FINGER TO NOSE:

Copenhaver III swayed while standing still. Copenhaver III did not keep his feet together as instructed. Copenhaver III missed the tip of his nose on several attempts. Copenhaver III raised his left finger once when I gave a command to use his right finger. Copenhaver III did not keep his eyes closed or his head tilted back for the entire roadside as instructed.

ROMBERG ALPHABET:

Copenhaver III swayed while standing still. Copenhaver III did not keep his feet together as instructed. Copenhaver III missed several letters on his first attempt to recite the alphabet. Copenhaver III stated he could not recite the alphabet unless he sung the song. Copenhaver III began to sing the alphabet song and still missed several letters. Copenhaver III did not keep his eyes closed or head tilted backward for the entire roadside as instructed.

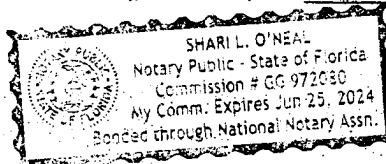
