Commission (FWC) was on water patrol on Lake Boca in Palm Beach County Florida. While there I observed a vessel (bearing Florida registration #FL6579MY) with several occupants on board causing a potential overloading hazard. I immediately pulled this vessel over and observed operator Robert Pavlick JR (identified by Florida driver's license #P142-760-84-007-0) for a vessel safety inspection.

Upon speaking with operator Pavlick I was immediately overtaken with the smell of alcohol. I observed his eyes as glossy and his ability to focus on attention on my directions difficult. I asked Pavlick to retrieve all the required safety gear on the vessel for his multiple passengers. I had to repeatedly give the same directions to Pavlick due to his constant laughing and inattention to the tasks given. Pavlick had a strong slurred speech while interacting with me and was unable to located enough life jackets (PFDs) on board the vessel.

Due to my observation thus far I asked Pavlick if he would board my vessel to perform seated field sobriety tasks on the bow of the vessel.

Pavlick agreed and then performed SFST's with the following results:

HGN: 6 Palm Pat: 6

Finger to Nose: 16 Hand Coordination: 5

Due to my observation prior to the stop, during the initial stop, boating safety inspection, and poor performances on seated field sobriety tasks, I place him under arrest for BUI. Pavlick was handcuffed and transported on our vessel to Spanish River Park where he was given the opportunity to offer a breath sample but refused.

Pavlick is charged with:


