The victim in this case invoked their rights under Marcy's Law.</p> <p>At 1958 hours, Palm Beach Police Department (PBPd) responded 223 Royal Poinciana Way, Palm Beach, FL for a disturbance. Upon my arrival I made contact with the victim Charles Farojens (B/M DOB 03/03/1996). Farojens is security officer for The Breakers Hotel. Farojens stated he responded to a Breakers property, a store named Main Street at 223 Royal Poinciana Way in reference to a guest refusing to wear his mask and using profanity at the employees. Farojen made contact with the guest later identified as Buffington. Buffington refused to put on a mask and yelled "Who do you think you are you are just a nigger officer" then continued to use foul language towards Farojen and the store clerk yelling "I don't have to wear a fucking mask". Farojen then asked Buffington to leave the store. While in front of the store Buffington rushed Farojen running into him and tried to tackle him. He then snatched the radio from Farojen and threw it to the ground. Buffington then slapped Farojens on the back as he slipped and fell down. Farojens did not react and Buffington attempted to leave the scene. This was captured on Breakers security surveillance video. The Breakers Hotel advised the replacement cost of the radio that was not working properly after it hit the ground was also missing its volume knob and had a broken antenna this was a new radio estimated to be over two thousand dollars.</p>
