The caller was a third party, later identified as Christopher Bennardo, who advised an adult male strangled a juvenile approximately 30 minutes prior.								
	Upon arrival, I made contact with the victim, _____ who advised the following: He has been on the soccer fields at the park coaching children's sports. He and another man, later identified as Robert Estell, who he met a couple of weeks ago, coach the same team. Estell's son plays on the team that they both coach. Estell's son was not playing well so _____ called him off the field and replaced him with another player. Estell got upset by this and confronted him. _____ advised that Estell said if _____ spoke like that to his son again, he would knock his teeth in. _____ responded by advising he would report what Estell said to the league administrators. Estell shoved _____ with his shoulder and then grabbed _____ by the throat with both hands. _____ was unable to breath during the incident. _____'s friend, Nicholas Simoneini, came over and separated the two of them. _____ never touched or hit Estell during the altercation. He did not call the police because he wanted to finish the game. After the game, he was approached by Bennardo who called the police on his behalf.								
S T A T E M E N T	Simoneini advised the following: He saw Estell approach _____ and have a conversation, he did not hear the conversation. Estell began to walk away and Simoneini heard _____ tell Estell that he would report that to the league administrators. Estell ran back over and shoved _____ and then grabbed him by the throat with both hands. Simoneini demonstrated how Estell grabbed _____ which was one hand behind his neck and the other on his throat. Simoneini went over to separate the two of them. While separating them he pried Estell's fingers from _____ throat. Estell left the area with his son shortly after. Simoneini had Estell's phone number because they had coached a few games together before. He provided me with the phone number.

The caller, Christopher Bennardo, advised the following: He did not witness the entire incident but he heard a scuffle, turned around and saw a man lifting and dragging a juvenile by the throat with both hands. He did not know either parties but recognized them from previous games. Bennardo identified the juvenile as being [REDACTED] Bennardo saw another male, who he pointed out as being Simoneini, separate the two of them. He approached the adult (Estell) to intervene and heard Estell say "did you hear what he said to me" before leaving.

I spoke to three other witnesses: Randall Sequete, Jill Thompson, and Adria Venger. All three were individually sitting with their own families at the time of the incident and do not know the involved parties beyond recognizing them from previous games. They each advised that they heard a commotion and saw an adult male holding and dragging a juvenile buy by his throat. They did not see the events leading up to the incident.

I spoke with Estell over the phone, and he advised the following: He had been getting upset with [REDACTED] because he was extremely aggressive with the children he was coaching. Estell had talked to [REDACTED] several times about not shouting at the kids and being more supportive of them. After Estell yelled at his son and took him out of the game he approached [REDACTED] again. [REDACTED] became belligerent and told Estell that his son was a terrible player and was cursing and screaming at him. [REDACTED] then pushed Estell in the chest and punched him in the face. Estell later changed his statement and advised that [REDACTED] punched him in the chest. When I asked for clarification, he advised that he punched him in the throat and chin area. He advised he had no visible injury from the strike. After [REDACTED] pushed and hit him, he stepped back for a moment and then advanced on [REDACTED] and grabbed him by the collar out of self-defense. When asked if he grabbed [REDACTED] by the throat, he advised that he doesn't think so. Estell advised that he left because he had to take his son to another game at a different location.

After speaking with Estell I contacted Sequete, Thompson and Venger again. I was unable to get ahold of Bennardo. I confirmed with them their original stories which remained the same. Sequete advised that due to his angle he was unsure of Estell's exact hand placement on [REDACTED]. Thompson and Venger both advised that they had a good view of the incident and that with absolute certainty Estell's hands were around [REDACTED] throat. They also advised that they could clearly see redness on [REDACTED] throat following the altercation. All three also advised that they had been watching the game that [REDACTED] was coaching and that at no point did they witness him be anything less then supportive of the children playing and in no way was he demeaning to the children.

At the time that I arrived, [REDACTED] did not have any visible redness or bruising to his throat. Simoneini advised he had taken a picture of the redness shortly after the altercation which he later sent to me. The photo was saved as evidence.
