Estell's son was not playing well so called him off the field and replaced him with another player. Estell got upset by this and confronted him. Advised that Estell said if spoke like that to his son again, he would knock his teeth in. The responded by advising he would report what Estell said to the league administrators. Estell shoved with his shoulder and then grabbed by the throat with both hands. We was unable to breath during the incident. First friend, Nicholas Simoneini, came over and separated the two of them.
