THE DEFENDANT DID THEN AND THERE DRIVE OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE TO WIT: 2016 CHRYSLER 300 BEARING FL TAG # 91DEQ. WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE AND/OR A CHEMICAL/CONTROLLED SUBSTANCE TO THE EXTENT HIS NORMAL FACULTIES WERE IMPAIRED. THE DEFENDANT WAS OBSERVED BY SECURITY DRIVING THE WRONG WAY ON 1ST AV N AND STRUCK A VEHICLE THAT WAS PARKED ALONG THE SOUTHERN CURB LINE. 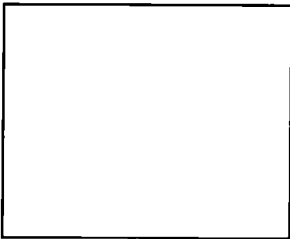
