The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 06 day of JUNE, 2020,

at approximately 11:15 PM, at 4800 34TH ST N, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE THE VICTIM, HIS GIRLFRIEND OF THREE YEARS THAT HE CO-HABITATS WITH, AGAINST THE VICTIM'S WILL. THE TWO OF THEM WERE STAYING THE NIGHT AT THE RAND MOTEL DRINKING ALCOHOL WHEN A VERBAL DISPUTE ESCALATED. THE DEFENDANT ALLEGEDLY GRABBED THE VICTIM AND PHYSICALLY SHOVED HER AROUND THE ROOM KNOCKING HER INTO THE WALLS. AS THE VICTIM TRIED TO HOLD ONTO A BACKPACK AND BAG OF HERS THE DEFENDANT DRAGGED HER ACROSS THE ROOM FLOOR, OUT THE DOORWAY, AND ONTO THE SIDEWALK. THIS CAUSED SUCH A COMMOTION THAT THE MOTEL MANAGER HEARD IT, AS DID OTHER GUESTS. THE DEFENDANT FLED THE SCENE ON FOOT AFTER HE WAS TOLD POLICE WERE BEING CALLED. THE VICTIM HAD NO VISIBLE INJURIES BUT WAS EMOTIONAL. DEFENDANT DENIES SHOVING OR DRAGGING THE VICTIM.

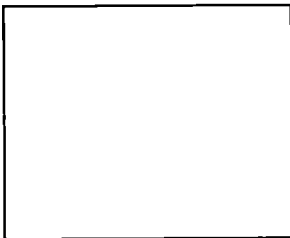
