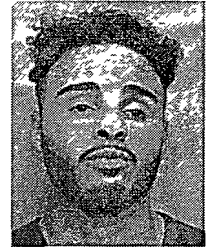

PROBABLE CAUSE

Before me this date personally appeared (Officer Sean Yap), who being first duly sworn deposes and says that on the 7 day of May 2017 at 440 SW 145 Ave the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

The def was causing a disturbance within the establishment and was issued a permanent trespass warning by the bar manager in my presence. The def was then given several lawful commands to leave the property of the establishment to which he refused and walked in my direction.

The def. was then advised that he was under arrest for trespass after warning. Once the def. was placed into handcuffs (finger gapped and double locked), he started to resist arrest by pulling away and tensing his arms. The def. was then escorted to the police vehicle at which point Ofc. D. Martin and I attempted to place him in the back of my police vehicle. The def. attempted to exit the vehicle twice until he was able to be successfully placed within the back seat of the vehicle.

It should be noted that the defendant was intoxicated at the time of the arrest.

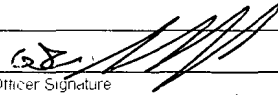

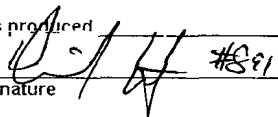
