The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On the above listed date, time, at the above listed location, I observed the defendant to be in actual physical control of a black Ford F150 (FL:U25TY / VIN: 1FTRX17L9XNB99989) by being seated in the driver's seat with the vehicle's keys located in the cup holder next to the driver seat. The vehicle was rendered operable during the investigation. Upon contact with the defendant, indicators of impairment were observed to include glassy eyes, slurred speech, unsteady balance, and the odor of an alcoholic beverage emitting from his breath. Standardized Field Sobriety Exercises were started but the defendant refused to complete all Standardized Field Sobriety Exercises. The defendant was arrested for DUI and later refused to provide two lawful breath samples after Implied Consent was read by stating, "no I'm not". The defendant was identified via FL DL.
