On October 7, 2020 at approximately 2323 hours I was on routine patrol in the area of West Indiantown Road and Central Boulevard in the Town of Jupiter, Palm Beach County, Florida.

I was traveling west. I observed a 2021 Kia which I later found to be bearing Florida license plate JTWH85 facing north on the south side of the intersection. The vehicle was clearly to the left of the solid median and in the southbound lanes of travel. I activated my emergency lights and stopped directly in front of the vehicle. The registered owner, Ronn Vanderhoff, was driving the vehicle. Vanderhoff was completely oblivious to why I was stopping him and that he was in the wrong lane of travel. The position of Vanderhoff's car had stopped an 18 wheeler semi from making a right hand turn from the eastbound lanes of West Indiantown Road to southbound South Central Boulevard. Vanderhoff had bloodshot, glassy eyes. Vanderhoff's speech appeared to be slurred and he had difficulty locating his insurance card by navigating an app on his phone. Vanderhoff admitted to drinking one beer. Vanderhoff stated he'd come out of the gas station and a fast moving car caused him to turn the wrong way. During my 10+ years at the Jupiter Police Department, I cannot recall one single time where I saw a vehicle travel in the wrong lanes in this area of town.

I relocated my car to the parking lot immediately adjacent to the location of the stop for the purposes of completing roadside tasks. I had Vanderhoff exit his car and we relocated to the parking lot in front of my car. I advised Vanderhoff I was concerned he was driving under the influence. Vanderhoff advised he does not have any medical conditions and takes no medicine. Vanderhoff stated he'd had two beers when I asked again how much he'd had to drink. Vanderhoff agreed to complete roadside tasks.

I first conducted the Horizontal Gaze Nystagmus task. I am a certified Drug Recognition Expert and conducted the task in a manner consistent with my training and experience.

I observed all three clues of Horizontal Gaze Nystagmus in both of Vanderhoff's eyes. I observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation and onset of nystagmus prior to 45 degrees in both of Vanderhoff's eyes. Vanderhoff was talking throughout much of the task and I had to remind him to keep his head still several times.

I next conducted the Walk and Turn task. Vanderhoff lost his balance from the starting position. Vanderhoff started the task early three times, in spite of instructions to wait to be told to start. Vanderhoff stepped off the line on the fourth step. Vanderhoff missed heel to toe on the ninth step. Vanderhoff then stopped and asked what he should do. Vanderhoff then walked backwards nine steps and did not attempt to turn around.

I next conducted the One Leg Stand. Vanderhoff put his foot down immediately upon raising it and then did the same thing again. Vanderhoff then raised his foot again. Vanderhoff was swaying side to side several times during the task. Vanderhoff put his arms out for balance and put his foot down at "1000-19." Vanderhoff then kept his hands out to the side until I terminated the task at "1000-24."

I next conducted the Finger to Nose. By this point Vanderhoff was becoming visibly annoyed and impatient. I observed the following: L1: Vanderhoff touched his nose over his right nostril before moving his finger to the tip of his nose. R2: Vanderhoff touched the tip of his nose with the first knuckle from the end of his finger before moving it to the tip. L3: Vanderhoff touched his nose as instructed. R4: Vanderhoff touched the tip of his nose with the pad of his finger. R5: Vanderhoff started to use the wrong hand, switched and then touched his nose with his finger near the second knuckle. L6: Vanderhoff touched his nose over his right nostril before moving it to the tip.

I then conducted the Alphabet Recitation exercise. Vanderhoff stated the alphabet as follows: "A B C D E F G H I N Double I messed up [giggles] A B C D E F G H I L G J [inaudible mumbling] X Y I, I'm sorry."

I then advised Vanderhoff he was under arrest for DUI. Vanderhoff expressed shock and disbelief at his being arrested. I placed Vanderhoff in handcuffs which I checked for spacing and double locked. I then secured Vanderhoff in the rear of my police car. I transported Vanderhoff to the Palm Beach County Breath Alcohol Testing Facility. As transport commenced Vanderhoff asked to take a breathalyzer. I then conducted a 20 minute observation period facing Vanderhoff. Vanderhoff was irritable and generally argumentative regarding the circumstances of his arrest during this time, admonishing me for arresting him but not burglars/looters/other assorted miscreants. Vanderhoff stated he Vanderhoff was fixated on the reason for the stop, confusing the stop with the reason for his arrest, in spite of my repeated attempts to earnestly explain the

difference to him.

Upon completion of my observation period, I requested Vanderhoff provide a sample of his breath. Vanderhoff initially said "yes." Vanderhoff then started asking questions regarding whether or not he should provide a sample. I read Implied Consent to Vanderhoff. Vanderhoff stated he understood. Vanderhoff asked my opinion, which I told him clearly I could not give to him, several times. Vanderhoff asked if he would be in trouble for the "beer and a half" he drank. Vanderhoff asked other questions such as if he was "doomed" and expressed he was concerned his breath sample would be over the limit. I attempted to answer Vanderhoff's questions truthfully and refused to answer any questions regarding my opinion. Vanderhoff remained fixated on the reason for the stop. Vanderhoff expressed he was "scared" and had great difficulty reaching a decision, repeatedly asking for my input. Vanderhoff then said yes but a few minutes later vacillated again and eventually stated he was refusing. I took the refusal at 0048 hours. I then secured Vanderhoff in a holding cell while I completed my paperwork. I subsequently booked Vanderhoff into the Palm Beach County Jail for the offense of DUI per FSS 316.193(1)(A).

My on scene interaction with Vanderhoff was captured on my issued body worn camera. My dash camera was later uploaded to evidence.com for future use in this case.

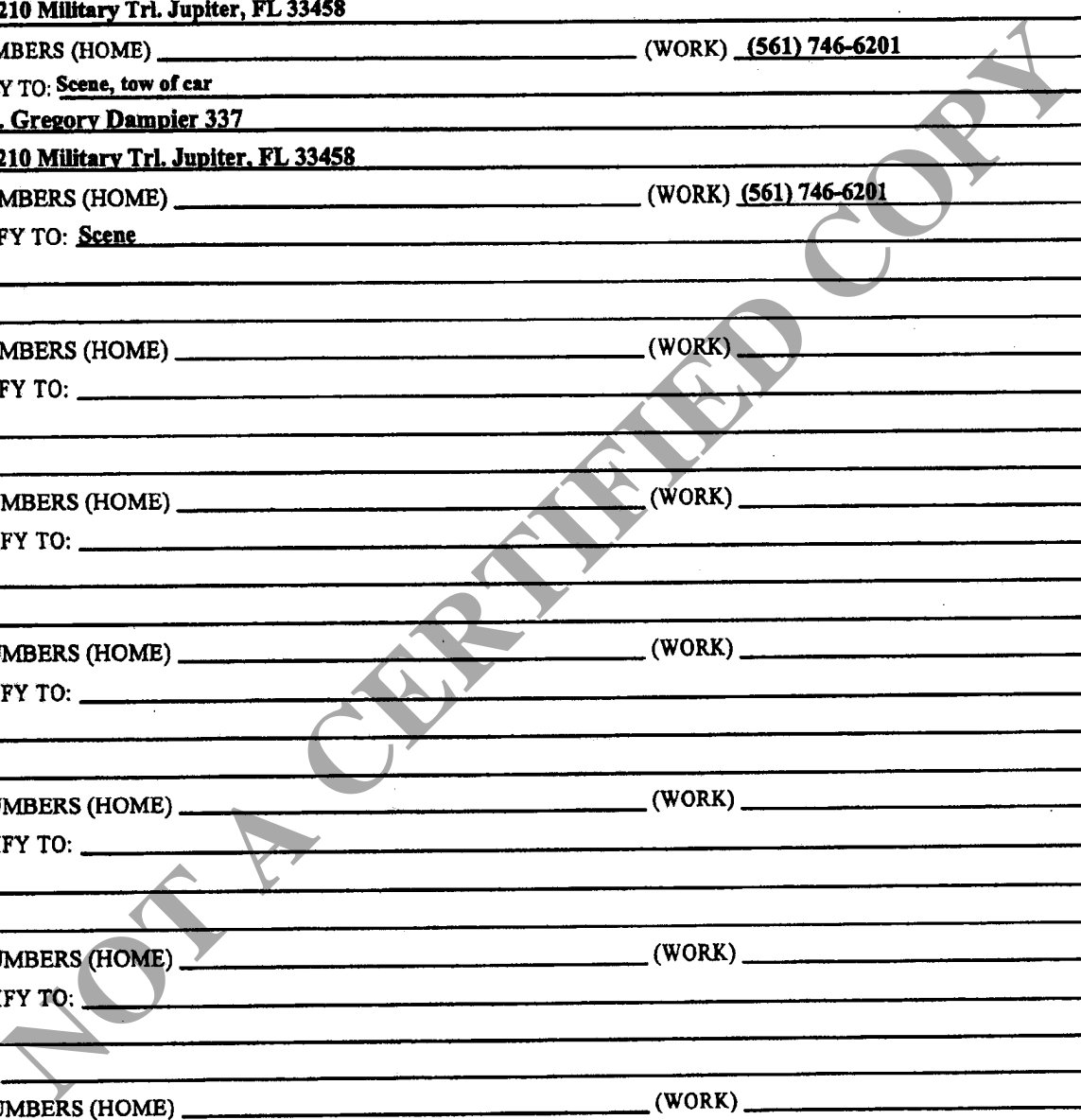
