The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/18/2021, at approximately 1849 hours, I responded to 7512 Surrey Pines Dr. Apollo Beach, Fl. 33572, to assist Deputy Route (ABN:210966) with a traffic crash (89447950). The amount of damage done during the traffic crash estimated to be, \$1,100.00. The vehicle that was struck in the traffic crash did not have any passengers and was stationary. The witness observed the defendant in the driver's seat of the vehicle during the traffic crash. The witness advised the defendant he needed to stop due to striking another vehicle. The witness identified the defendant via clothing and appearance. When I made contact with the defendant, I observed him to have watery/glassy eyes, slurred speech, and was unstable on his feet. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant elected to provide lawful samples of his breath after a twenty minute observation period. The breath samples were recorded at .113 and .116. The defendant was identified via Florida driver's license.
