On February 9, 2022 I was stopped on Interstate 95 (State Road 9) at the southbound exit ramp to State Road 798 (Palmetto Park Road) for traffic control due to a traffic fatal crash south of my location. While stopped, I observed a white passenger car passed through the southbound Interstate 95 traffic control device (cones) which prevented vehicles from entering southbound Interstate 95. I then activated my lights and siren and traveled southbound to conduct a traffic stop on the vehicle. When I got behind the vehicle with my lights and siren activated, the driver slowed down to the right shoulder of the roadway and then speed off, driving around me and continued driving south. I then get on the public address (PA) speaker and gave the driver the command to stop while my lights and sirens were on. The driver refused to stop and continued driving south where he then stopped north of the fatal traffic crash. The white passenger car was a 2020 Mazda 6 bearing Florida Tag CKQD08.

I then approached the vehicle and identified myself. I observed the driver was the sole occupant of the vehicle. The driver was identified by his Florida Driver's License (G400-724-71-289-0) I smelled an odor of unknown alcoholic beverage emanating from (Mr. Russell David Gallahue) facial area. I had the driver step out of the vehicle and walk towards my patrol car. I then observed that he had an orbital sway and the odor of unknown alcoholic beverage was emitting from his breath as he talked. I then requested that he conduct field sobriety exercise and he refused. The driver Mr. Gallahue asked why he was getting pulled over and it was explained multiple times that I was conducting a DUI investigation. Taylor warning was then read, and he said he understood and refused again. He was then place under arrest for DUI. Trooper Horlkins Saget (1629) upon conducting vehicle inventory found a clear plastic container of Marijuana weighing 9.6 grams. I asked Lake Worth Regional Communication Center (LWRCC) to run the driver to see if he had a marijuana prescription card and they advised that he did not.

He was secured inside of my patrol car and transported to the county jail. At the testing facility I conducted a 20-minute observation. At no time did he regurgitate or take anything by mouth. I then requested

that he provide a lawful sample of his breath and he refused. Implied consent was read, and he stated he understood. He then refused again to provide a sample.

He was then book into the Palm Beach County Jail on DUI charge of 316.193. I advised Mr. Gallahue he was under arrest for DUI and he stated no and pulled his arm away from me when I attempted to place my handcuffs on his wrists.

All above incident occurred in Palm Beach County.
