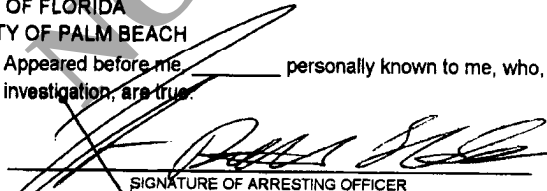

On 3/5/2022 at approximately 0309 I was dispatched to 820 15th Street on the report of two males involved in a fight. On scene I spoke with the victim, Ryan Sheldon (W/M 6/11/1997) who advises that he was battered by the offender, Ryan Bandemer (W/M 4/23/1980). Sheldon stated that Bandemer punched him in the face with a hard closed fist and punched him in the crown of his head with a hard closed fist. Sheldon presented with abrasions

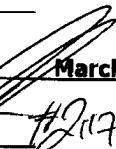

	to the crown of his head, and minor swelling to his face. Sheldon had video evidence that led me to determine that Bandemer was the primary aggressor. Bandemer presented with a broken left wrist. Bandemer and Sheldon were in a sexual dating relationship. Ryan Bandemer (W/M 4/23/1980) who presented with a possible broken left arm. Bandemer states that he was battered by Ryan Sheldon (W/M 6/11/1997). Bandemer requested to be seen by medics for his injury. West Palm Beach Fire Rescue (WPBFR), Rescue 1 responded. WPBFR's run number is 22005524, Lt. Hernandez was the supervisor for Rescue 1. Bandemer states that Sheldon and himself had been out in the city (West Palm Beach) drinking and going to different bars. Upon returning to the Airbnb Sheldon was angry and Sheldon kept placing his phone in Bandemer's face. Bandemer stated that after a while he punched at Sheldon's phone. Sheldon subsequently "jumped" all over Bandemer, and at some point Bandemer "broke" his arm. WPBFR transported Bandemer to Good Samaritan Hospital to treat his injuries. I spoke with Sheldon who advised that he and Bandemer arrived at the Airbnb after leaving a bar. Sheldon states that he and Bandemer were on the porch of the Airbnb. They kept knocking at the door because they did not have a key to get in. Sheldon states that Bandemer began getting agitated about not being able to get into the Airbnb. Sheldon states that Bandemer and himself have had domestic issues in the past. Sheldon states that Bandemer punched him in the face with a closed fist and then struck him in the crown of his head with a closed fist. Sheldon refused any medical treatment. I spoke with the complainant, Beatrice Kobran (W/F/H 8/16/1947) who advises that she was in her home sleeping. She awoke when she heard the yelling on the front porch. When Kobran went outside she states that Sheldon and Bandemer were yelling at one another, and that Bandemer complained that his arm was broken. Kobran called dispatch to start Medics and Police services. Kobran has a camera on the front of home facing directly towards the porch area. Her and I tried to access the saved video, but she was unsure of how to work the system. I will follow up with Kobran and her husband tomorrow evening to determine I will be able to retrieve the camera footage from them. At this time Kobran states that her husband is the only one that knows how to work the camera system. I went back to speak with Sheldon again. Sheldon showed me video footage that he had recorded on his phone. The video footage shows Sheldon and Bandemer placing their phones in each other's faces while actively recording. Both Sheldon and Bandemer are visibly and audibly intoxicated. Sheldon begins asking Bandemer "why don't you fuck me every day", and after repeating himself a couple of times, I observed Bandemer use his right hand to make a fist, draw his arm back, and punch at Sheldon. The video turns off after that point. In a second video, I observed that Sheldon and Bandemer had separated from one another, and Bandemer is observed running towards Sheldon with his arms outstretched as if to grab ahold of Sheldon. Based on this video footage, the statements given by Sheldon and Bandemer, and the totality of the circumstances I have determined Bandemer to be the primary aggressor. I took photographs of Sheldon and Bandemer, as well as their reported injuries. They have been uploaded to Evidence.com. Video footage from my BWC has been uploaded to Evidence.com. Sheldon was given a copy of the Maray's law packet. The victim notification form was completed. Sgt. Louis was called and advised of the nature of the incident. I placed the victim notification form and the officer receipt of the victim's right packet in the Sergeant's bin at HQ.

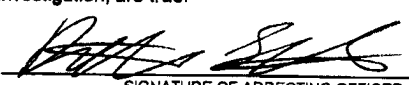
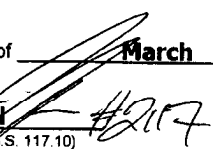
