The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2014 Ford Focus (FL TAG #JTUA39) eastbound on Platt St W at night without having his headlights illuminated. During the traffic stop for the infraction, the defendant was slow to react/stop, and was identified via a FL DL. During our encounter, the defendant displayed several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, very poor balance, appeared tired/lethargic, moved with slow/deliberate movements, admitted to drinking alcohol prior to driving, and emitted a distinct odor of an alcoholic beverage from his breath. The defendant was arrested for DUI following a poor performance on SFSEs. While at CBT, the defendant provided 2 valid breath samples, measuring .119/.118 BrAC.
