On the 16 day of November, 2020 at 05:17 (Specifically include facts constituting cause for arrest.)

I utilized my body worn camera.

On November 16th, 2020 at approximately 4:10am, I, Officer Bennett observed a silver in color Dodge Caravan parked in the fire lane at 228 East Blue Heron, Riviera Beach, Florida. The driver who was later identified as Ryan Verbeck (W/M DOB 9-9-88) was asleep in the front seat of the vehicle with the keys in his lap. When officers made contact with Mr. Verbeck he was disoriented and appeared to be having issues staying awake. Mr. Verbeck opened the driver door to the vehicle which set off the vehicles alarm. I assisted Mr. Verbeck with turning the vehicle alarm off using his key fob. I then observed in plain sight, a green plastic container protruding from Mr. Verbecks left front pocket. Inside the container I observed a white plastic bag and a small white pill. Mr. Verbeck was detained and later spontaneously uttered that the pills were Xanax. The pills were counted and weighed by Officer Dantzler which amounted to Thirty Four (34) Full Alprazolam (Xanax) Pills and Eight (8) Half Alprazolam (Xanax) Pills. Officer Dantzler weighed the container using a calibrated Ohaus Triple Beam Balance Scale at 24.7 Grams with the pills inside of the green plastic container. The Green plastic container alone weighed in at 14.4 Grams.

The pills were collected, photographed and submitted into evidence by Officer Dantzler.

Mr. Verbeck was arrested and transported to the Riviera Beach Police Station (600 West Blue Heron, Riviera Beach, Florida). Mr. Verbeck was read his Miranda rights and advised that he had the Xanax pills in the green plastic container because he wasn't sure it was legal to drive around with them in their original prescription bottle.

Sheehans Towing responded and towed Mr. Verbecks vehicle to their tow yard.

Mr. Verbeck was then transported to the Palm Beach County Jail for 1 Count Possession of
