The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 09 day of FEBRUARY, 2020, at approximately 7:40 AM, at 25 N BELCHER RD #130, in Pinellas County did:

THE DEFENDANT DID KNOWINGLY AND INTENTIONALLY, AGAINST THE WILL OF ANOTHER, IMPEDE THE NORMAL BREATHING OR CIRCULATION OF THE BLOOD OF A FAMILY OR HOUSEHOLD MEMBER, SO AS TO CREATE A RISK OF OR CAUSE GREAT BODILY HARM BY APPLYING PRESSURE ON THE THROAT OR NECK OF ANOTHER PERSON TO-WIT: (SUSPECT RYAN FELDHAUS WRAPPED HIS FOREARM AROUND THE THROAT OF VICTIM JACLYN MURDOCK, WHILE DRAGGING VICTIM MURDOCK TO A BEDROOM. VICTIM MURDOCK STATED THAT SHE COULD NOT BREATHE DURING THE ALTERCATION. FELDHAUS AND MURDOCK RESIDE TOGETHER AND SHARE A CHILD.)

ON 2/9/20 AT 0703 HRS. I RESPONDED TO 25 N. BELCHER RD. #130 ON A DOMESTIC BATTERY CALL, UPON MY ARRIVAL I SPOKE WITH VICTIM JACLYN MURDOCK AND SUSPECT RYAN FELDHAUS. MURDOCK ALLEGED THAT FELDHAUS GRABBED HER FROM BEHIND AND PLACED HIS FOREARM AROUND HER THROAT WHILE DRAGGING HER INTO A BEDROOM DURING AN ARGUMENT. MURDOCK STATED THAT SHE COULD NOT BREATHE DURING THIS BATTERY. IN SPEAKING WITH FELDHAUS HE ADMITTED TO GRABBING MURDOCK FROM BEHIND AND PLACING HIS FOREARM ACROSS HER THROAT WHILE TAKING MURDOCK INTO THE BEDROOM. FELDHAUS STATED THAT HE LET GO OF MURDOCK WHEN SHE QUIT RESISTING HIM. FELDHAUS CLAIMED THAT MURDOCK DID NOT LOSE CONSCIOUSNESS, MURDOCK ALSO DENIES LOSING CONSCIOUSNESS. THE ALTERCATION HAPPENED INSIDE THE RESIDENCE WITH THE COUPLE'S SIX YEAR OLD DAUGHTER.

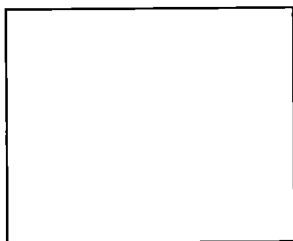
