The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/29/2020, the defendant and the victim were engaged in a verbal argument. The argument turned physical when the defendant knowingly and intentionally used both hands to push the victim in her upper chest, causing the victim to press against the wall. The defendant then proceeded to grab the victim by the hair, while screaming in the face of the victim. The victim did not sustain any injuries during the incident.
