Ryan Preston was observed at the wheel of his white Chevy sedan (FL GVQG16) at the listed intersection. The keys were in the ignition and the car was in park. During observations Preston displayed indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on his breath.
