The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/15/2020 at 0230 hours I conducted a traffic stop on a dark gray 2015 BMW sedan, FI tag KRTY43 after I observed the vehicle speeding and almost striking two other vehicles at it traveled northbound on Howard Av N from Kennedy Bl W. Upon contact with the driver of the vehicle, defendant Ryan Valdes, I observed that his right eye was bloodshot and glassy. Then as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. The defendant was not very cooperative and was reluctant to exit his vehicle after I asked him to. The defendant then refused to perform the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0245 hours. I then transported the defendant to the HCSO/CBT Facility where he submitted to a breath test. His BAC was .163/.148. I identified the defendant with a valid FL DL. He was the only one in the vehicle.
