S T A T E M E N T	On 4/30/22 at approximately 2118 hours, I responded to 180 S Federal Hwy (Salt and Spirits) in reference to a battery. The caller advised that two couples had engaged in a fight near the bar and both parties were now separated. Upon arrival, I made contact with Karli Adams and Ryan Stewart, who advised they had been attacked by V1 and V2. It should be noted that both Karli and Ryan were both intoxicated and had a difficult time describing in detail the incident. Additionally, Robert was being confrontational and had to be detained with handcuffs during the investigation.								
	I attempted to get Karli to describe the incident and she stated the following: While she was standing at the bar with her boyfriend, Ryan, she believed V1 and V2 may have taken her wallet from the bar. Karli and Ryan began shouting back and forth at V1 and V2. V1 approached Ryan and the two began fighting. Karli continuously changed the topic of conversation and could not stay on track. She did, however, advise that during the fight she kicked V2 in the face.								
A D M I N I S T R A T I V E	I attempted to gain Ryan's side of the story, but he was belligerent and refused to cooperate with the investigation. After several times of telling Ryan to calm down, Officer Rochetti and I informed Ryan that he was being detained and I placed handcuffs onto Ryan that were double locked and checked for tightness.								
	I spoke with V1 and V2 who stated the following: V1 and V2 were seated at the bar, when Karli and Ryan were attempting to order drinks. Karli placed a credit card inside a billfold and left it at the bar. Ryan approached them and stated he and Karli were trying to pay their bill. Ryan then began accusing V2 of stealing Karli's wallet. The four individuals began arguing back and forth and Ryan pulled V1 down from the back of his chair and V1 fell to the floor. V2 advised of neck injuries from the incident. While V1 was on the floor, V2 also fell down to the floor and was attempting to help V1 off the ground. During this process, Karli kicked V2 in the right side of her jaw, causing

her pain. Patrons of the bar began pulling Ryan and Karli away to avoid any further confrontation. W1 was interviewed by Officer Rochetti, who confirmed the same statements given by V1 and V2. The owner of the bar arrived on scene and allowed me to view the footage of the incident. The statements given by V1 and V2 were accurate. After the four individuals can be seen arguing back and forth, V1 and V2 never left their seats at the bar. Ryan can be seen aggressively approaching V1, and V1 extends his arm to create distance and defend himself from Ryan. Ryan grabs V1 by the shoulders and V1 grabs Ryan's shoulders, where the two begin to wrestle to the floor. V2 can be seen on all fours on the floor when Karli uses her right foot and kicks V2 in the face. Based on the above information and my investigation, I found Ryan Stewart to be in direct violation of F.S.S. 784.03(1A1) for simple battery. He aggressively approached V1 and unwantedly placed his hands on V1 where he wrestled V1 down to the floor. This was confirmed by an independent witness and video surveillance. Ryan Stewart was transported to Palm Beach County Jail where he was turned over to jail staff.
