The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2015 black Nissan Altima bearing a MA license plate of 6VW364. She was traveling west on Cypress near Armenia and made a very wide left turn onto Armenia. I followed the defendant and as she approached a red light at Kennedy Blvd she stopped a full city block prior to the light (stopped at W North A st, and there were no obstructions between her vehicle and the red light). Additionally, at another red light the defendant stopped over the line of prolongation (stop bar), and made a left turn from the far right lane at another intersection. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (one Vodka drink). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .204 and .196.

The defendant was identified by her MA DL.
