The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 13 day of MAY, 2020, at approximately 12:09 AM, at 6270 150TH AVE N CLEARWATER, FL 33760, in Pinellas County did:

DID THEN AND THERE ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE TASHIYUNIA FLOWERS AGAINST THE WILL OF TASHIYUNIA FLOWERS AND DID CAUSE BODILY HARM. BORJI ENCOUNTERED FLOWERS INSIDE THE 7-ELEVEN AT THE ABOVE ADDRESS. THEY BOTH HAVE A HISTORY OF DISTURBANCES DATING BACK TO MIDDLE SCHOOL. BORJI GRABBED THE VICTIM BY THE BACK OF THE HAIR, RIPPING OUT A PIECE OF HAIR, AND TOOK HER TO THE GROUND WHERE SHE PUNCHED HER SEVERAL TIMES. AN UNKNOWN SUBJECT ALSO STRUCK FLOWERS AND PEPPER SPRAYED HER WHILE BORJI WAS ON TOP OF HER. VICTIM WAS ABLE TO GET OUT OF THE STORE AFTER THEY WERE SEPARATED BY OTHER CUSTOMERS. VICTIM HAD A BUMP ON HER HEAD AND A CUT ON HER LEG SUSTAINED DURING THE FIGHT. BORJI ADMITTED TO THE OFFENSE STATING SOME WORDS WERE INITIALLY EXCHANGED.

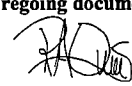

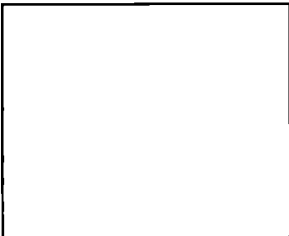
