 On the **25** day of **March**, **2020** at **22:58** (Specifically include facts constituting cause for arrest.)

On March 25, 2020 I was on patrol in the area of Northlake Boulevard and Roan Lane, Palm Beach Gardens, Palm Beach County, Florida; in my marked patrol vehicle.

While on patrol, I observed a white Cadillac SUV, bearing Florida tag GHLF73 turn eastbound onto Roan Lane from Northlake Boulevard. The SUV turned at such a high rate of speed that I could hear the tires screeching. I then observed the driver aggressively turn into the Shell gas station located at 3905 Northlake Boulevard at a high rate of speed almost striking a vehicle in the parking lot, and abruptly stop in front of the store before quickly reversing next to a gas pump. I observed the driver exit his vehicle and enter the gas station at which point I pulled behind his vehicle and made contact with him as he was exiting a few seconds later.

I asked the driver, identified as Saher Yahya, why he was driving so aggressively to which he stated he was trying to get gas. I explained to Yahya that he was driving carelessly through the parking lot at a high rate of speed and almost caused multiple accidents. When I asked Yahya how fast he was going when he turned into the gas station, he stated approximately 60 mph. Additionally, I made contact with the Shell clerk who stated he observed Yahya's careless driving and said, "I thought he was going to rob the store because of how he pulled up". After explaining Yahya his traffic infractions that were made, he apologized saying he wasn't aware and gave permission to search his vehicle and anything I wanted.

Officer Barker searched the vehicle and located a ball of a white powdered substance in the center console area of the vehicle in plain view. A black glasses case containing two plastic containers and one plastic bag with a green leafy substance were also located on the passenger floorboard. Based on my training and experience, the white powdered substance appeared to be Cocaine and the green leafy substance appeared to be Marijuana.

I read Yahya his Miranda Right's from a pre-printed card to which he understood. Post-Miranda, Yahya stated he rented the vehicle today and has been the only person in possession of the vehicle. Yahya initially denied using any illegal narcotics or having any illegal narcotics. When I explained to Yahya that Marijuana was located in the vehicle, he confessed it was his. Yahya denied knowing anything about Cocaine in his vehicle.

I made contact with the front seat passenger, identified as Yahya Sheha, and read him his Miranda Right's from a pre-printed card to which he understood. Post-Miranda, Sheha stated he got picked up from school in Stuart by Yahya and they were traveling down to Miami to hangout and destress. Sheha stated he did not observe anyone bring any containers with Marijuana or Cocaine into the vehicle since he got picked up. When I asked Sheha if that means they were most likely already in the vehicle before he got picked up, he agreed.

I confirmed my suspicion about the green leafy substance utilizing a field test kit which provided a positive indication for the presence of Marijuana. I also confirmed my suspicion about the white powdered substance utilizing a field test kit which provided a positive indication for the presence of Cocaine. The total weight of the Marijuana was 32.1 grams and the Cocaine was 0.3 grams.

Based on the above facts and circumstances, Saher Yahya was placed under arrest and is being charged with possession of Marijuana over 20 grams, in violation of F.S.S. 893.13(6) (A). Yahya is also being charged with possession of Cocaine, in violation of F.S.S. 893.13. Yahya was transported to Palm Beach County Jail without incident.
