The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 10-19-2019, at approximately 0220 hours, at The Local bar located at 3841 Northdale Blvd. Tampa, FL 33624, the defendant was verbally arguing with witness #1 (female). The victim who is an employee at the bar walked out onto the front patio area to assist with another customer when he observed the argument. The victim got between witness #1 and the defendant and told the defendant to leave. After telling the defendant to leave several times, the defendant grabbed a beer bottle and swung it at the victim's head. The victim observed this and immediately put his arms up to block the bottle. The victim then put his arms around the defendant to avoid any further strikes to him. The victim and defendant both sustained minor injuries to their persons. The defendant positively identified the defendant as the person who committed the above offense.
