The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 10/18/2020, at approximately 0604 hours, near the intersection of Big Bend Road and Summerfield Boulevard, Riverview, Florida 33579 the defendant was observed by Deputy I. Struense ABN: 255682 operating a 2016 Mazda CX-5 bearing Florida tag PKIW60 with an assigned VIN of JM3KE2CY7G0786968 in the wrong lane of travel. Upon Deputy Struense's contact with the driver/defendant, he observed multiple indicators of impairment. Deputy Struense advised the vehicle corrected itself prior to making contact with his patrol vehicle. Upon the affiant's contact with the defendant, she had bloodshot watery/glassy eyes, slurred speech, she was unsteady on her feet, and I smelled the odor of an alcoholic beverage emitting from her breath. The defendant decided to participate in field sobriety exercise and while doing so, she showed further indicators of impairment. Post Miranda, the defendant admitted to consuming several alcoholic beverages earlier in the evening. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she provided two lawful breath samples .111 and .105. The defendant identified herself verbally. I further identified the defendant via a prior DAVID photograph.
