

Probable Cause

On April 30, 2022, at approximately 3:50 Am, I, Trooper Villarin, was dispatched by Lake Worth Regional Communications Center (LWRCC) to Interstate 95 (State Road 9) northbound entrance ramp to State Road 806 (Boynton Beach Boulevard) regarding a vehicle that collided with the median.

Upon arriving on scene, I made contact with Boynton Beach Police Department Officer C. Schalk. Officer Schalk advised me that he observed a gray Honda Accord stationary on the Interstate 95 northbound entrance ramp to Interstate 95 at Boynton Beach Boulevard. The vehicle had been in an obvious accident and collided with the metal guard rail. Officer Schalk also advised he walked up to the driver window and observed a white female wearing blue jeans and a blue top sitting in the driver seat slumped over the center console passed out. Officer Schalk stated he knocked on the window and the female became alert and opened the driver door. Officer Schalk also advised upon asking the female questions about the crash he could smell a strong pungent odor of an alcoholic beverage emitting from her breath the female thought she was in Delray Beach when she was in Boynton Beach. Officer Schalk stated her speech was extremely slurred and think. He continued to ask her questions about the crash, and she did not know what happened.

I approached the gray in color Honda Accord and made contact with the female,

identified by Florida Driver's license as Samantha Shea with a D.O.B. of 04/15/1995. I immediately observed Ms. Shea's bloodshot eyes and slurred speech as she spoke with me. I asked Ms. Shea's if there was any other occupant in the vehicle, and she stated she was the sole occupant of the vehicle. Based on Officer Schalk's statements and Mrs. Shea's stating she was the driver of vehicle, I determined Mr. Shea's was the driver of the vehicle.

As I got closer to Ms. Shea, I could smell a strong odor of an unknown alcoholic beverage emitting from her breath.

I advised to Ms. Shea that I had finished my crash investigation and, based on my observations, I would begin a D.U.I. Investigation.

I read Miranda Warnings to Ms. Shea, and she agreed to speak to me.

I asked Ms. Shea where she was coming from and she stated her friends house. I asked her where she was going, and she stated her house.

I asked Ms. Shea if she was willing to perform Standardized Field Sobriety Exercises (SFESs). Ms. Shea agreed to perform SFSEs.

I asked if the defendant was wearing contact lenses, and she was wearing contact lenses.

Each SFSE's exercise was explained and demonstrated prior to Ms. Shea attempt to perform the exercises. (VIDEO FOOTAGE AND AUDIO RECORDING CAPTURED BY IN CAR CAMERA AND MICROPHONE IS AVAILABLE UPON REQUEST).

Horizontal Gaze Nystagmus. (Streamlight red L.E.D. pen used as contrasting stimulus)

I checked for resting nystagmus which was not observed in either eye.

I checked for equal tracking and pupil size (Both pupils were equal in size and both eyes track the stimulus equally)

I observed lack of smooth pursuit in both eyes

I observed distinct and sustained nystagmus at maximum deviation in both eyes I observed onset prior to 45 degree in both eyes

Walk and Turn Exercise (Performed on a flat and debris free surface of a paved surface, and a yellow line was utilized during this exercise)

Ms. Shea was instructed to put her left foot on the line and right foot in front of the left foot, arms at her side, and hold this position until I told her to start, and Ms.

Shea did not stay in the initial position as instructed.

She started before I told her to start.

She was not touching heal to toe.

She stepped off the line and counted to ten steps and did not turn as instructed.

She walked off the line.

She counted to eleven steps on the way back.

One Leg Stand

I had to explain the exercise to Ms. Shea multiple times. She stopped counting and then continued the exercise. She had her foot above six inches and could not keep her balance. She put her foot down twice. During the exercise she was swaying. Based upon the performance of the above exercises and the totality of the circumstances, I determined that there was probable cause to believe that Ms. Shea committed the offense to driving under the influence by being in the actual physical control of the vehicle while under the influence of alcoholic beverage, and or any chemical substance, and or any controlled substance while her normal faculties were impaired.

Ms. Shea was placed under arrest at 2:53 am and transported to Palm Beach County Jail.

I checked Ms. Shea's mouth at the jail, and I confirmed it was empty. I initiated my 20 minutes observation period at 3:31 am, and during this 20 minutes the defendant did not ingest anything or regurgitate.

After the 20 minutes observation, Ms. Shea was brought into the intoxilizer room, and I requested Ms. Shea to provide a breath sample, and Ms. Shea stated she would provide a breath sample. Ms. Shea first breath result was a .214 and the second breath result was a .218

At 4:41 am, Ms. Shea was transported to Good Samaritan Hospital for clearance After being checked out at the Hospital, Ms. Shea was transported back to Palm Beach County jail, booked, and charged with DUI.

All the events above occurred in Palm Beach County, Florida.
