The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
Samantha Curran was driving a black Lexus ES350 bearing (FL QDCK83) that was stopped for unlawful speed. It was doing 77 mph in a 55 mph zone on the NB Crosstown Expwy. Its speed was confirmed using MPH Sure Shot hand held laser serial number FL10013. It cut in front of another vehicle to get off the expressway at the last moment and stopped was conducted on Cleveland St W. During observations Curran displayed indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on her breath. She denied consuming alcoholic beverages. She was arrested for DUI after she displayed additional indicators of impairment during SFST's. She was advised of implied consent before she was taken to CBT where she refused to take the breath test. Curran's identity was verified using her state of Florida drivers license photo from DHSMV.
