The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was observed driving westbound on Kennedy Bv W in a red Honda 4D bearing FL tag LZTT69. The vehicle was unable to maintain its lane and continued to drift to the left, causing the drivers side tire to cross the lane divider line. I also paced the vehicle at 51 mph in a 40 mph zone. The vehicle would alternate between accelerating and hitting the brakes. I suspected the driver to be sick, injured, or impaired and conducted a traffic stop on the vehicle. I came into contact with the defendant and observed him to have a strong odor of an alcoholic beverage emanating from his breath. His speech was slow and slurred and he attempted to hand me a valet parking ticket when asked for his drivers license. He admitted to having "4 beers", and his eyes were bloodshot and glassy. He participated in SFSE's which showed further indicators of impairment. The defendant provided breath samples of .221 / .225. A DHSMV check showed the defendants drivers license was suspended for Financial Responsibility on 02/26/20. The defendant was ID'ed via FL DL.
