The defendant was found by Officer M. Parrish passed out behind the wheel in traffic in the southbound left turn lane of 50th St N at Adamo Dr. The defendant was the subject of a call for service, and upon Ofc. M. Parrish's arrival was unconscious while stopped through multiple light cycles. The defendant's vehicle, a 2008 Infiniti SUV bearing FL tag #NCBC99, was running with the gear in drive and the defendant's foot on the brake. Upon making contact with the defendant, he displayed several signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, slurred speech, a sleepy and lethargic appearance, flushed face, and possession of an open cup of alcohol. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .175/.180.

The defendant identified himself via his FL driver's license.
