The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/20/2020, at approximately 0022 hours, at the Racetrac gas station located at 10032 Gibsonton Dr Sergeant Tagliarini #3759 contacted the defendant on a welfare check while he was at the gas station. Sgt. Tagliarini observed a female sitting in a white Kia crying. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. The vehicle was running with the keys in the ignition putting the defendant in actual physical control of the vehicle. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and provided two lawful breath samples of .172 and .174. The defendant was positively identified via a valid Florida DL
