They were involved in a verbal argument that became physical when the defendant intentionally grabbed the victim from behind with his arms and forced her against her will into the bedroom. The victim was able to break free of his grasp and ran back into the living room. The defendant followed the victim into the living room where he continued to slap the victim at least 3 times with an open hand, causing complaint of injury to the left side of her face.
