The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2016 white Toyota SUV bearing a Florida license plate of PGEN86. She was traveling west on Kennedy Blvd near MacDill Ave and stopped behind a marked police vehicle in the number two lane. This police vehicle had the emergency red and blue lights activated. After about five second the defendant began to drive around this police vehicle and she turned very wide, going across one full lane and into the center turn lane. The vehicle then made a wide right turn onto N MacDill Ave and as I followed I observed the vehicle weaving back and forth. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, unsteady stance, and inconsistent statements. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
