The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 10/23/2019, at approximately 0238 hours, Affiant observed a white Ford truck bearing FL tag FC7196 (VIN:1FTEW1EG1JFC56954) traveling westbound on Hillsborough Av W. The white Ford truck was observed traveling 69MPH in a posted 50MPH zone. Affiant conducted a traffic stop on the vehicle at Hillsborough Av W / Longboat Bl W in Tampa, FL and observed the defendant operating the vehicle. Affiant detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, she was slurring her speech, and her eyes were bloodshot and glass. Affiant requested the defendant perform Standard Field Sobriety Exercises SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). Incident to arrest, a custodial search of the vehicle was conducted and in the passenger seat Affiant located a black purse with a gold chain. Affiant asked the defendant if the black purse with the gold chain belonged to her and she stated it belonged to her. While searching the black purse with a gold chain Affiant located a small plastic bag containing a white powdery substance in the inner sleeve. Affiant conducted a field re-agent test on the white powdery substances and it rendered positive results for cocaine. The defendant refused to provide a lawful breath sample to determine her breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of Central Breath Testing, she understood and replied "Nope." The defendant was identified via passport and DAVID photo. The defendant was given a DUI citation AC19TNE which reflects the DUI charge. The defendant also received Uniform Traffic Citation ACRERGE or Speeding (69MPH in a posted 50MPH zone.)
