The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a 2016 white Kia four door bearing a Florida license plate of HPQG97. She was traveling west on Kennedy Blvd between Macdill and Lois. The defendant was traveling at inconsistent speeds during this time but was paced at 65 MPH for several blocks between Dale Mabry and Lois. This is a posted 40 MPH zone, and was paced with my calibrated and certified speedometer. The defendant was also weaving back and forth, crossing over the lane dividers. Furthermore, the defendant stopped beyond the line of prolongation at two different intersections when approaching a steady red light (North bound on MacDill at Kennedy and West bound on Kennedy at Dale Mabry). A traffic stop was conducted and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, slow and lethargic movements upon exiting her vehicle, an odor of an alcoholic beverage, and unsteady stance. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant was identified with her Florida Drivers License.
