The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time, at the above listed location, the defendant and the victim were engaged in a verbal argument that turned physical. When the victim grabbed a set of car keys that the defendant was holding. The defendant attempted to strike the victim with a closed fist and the victim was able to block the strike. The defendant later armed herself with a rock located in the master bedroom of the residence and threw the rock missing the victim. The rock was approximately five inches in diameter and approximately one inch thick. The defendant armed herself with a black and silver folding knife and charged at the victim. The victim attempted to disarm the defendant in self defense and sustained a laceration to his left ring finger. The defendant and the victim have been married for approximately eleven years, have lived together for approximately eleven years, and share three children in common.
