 The victim and defendant reside together as boyfriend and girlfriend. They have been dating for about 2 years and have lived together for about 1 year.

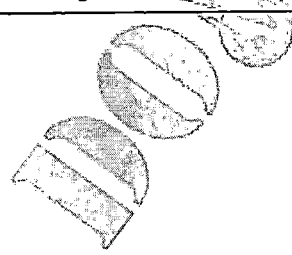
On August 16, 2020, the defendant and victim where in a verbal altercation outside their home. The victim pushed the defendant out of the house in order to prohibit the altercation from escalating. The defendant subsequently gained entry into the home they share. Once inside, the defendant continued the verbal altercation and began throwing miscellaneous items at the victim. The victim then picked up a plastic clock and struck the victim on the left side of his forehead. As a result, the victim suffered a laceration about 1 inch wide. The clock weighed about 1 to 1.5 lbs.

The victim identified the defendant on scene. She was positively identified via RMS photo.
