The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant, who was identified by her Florida driver's license, was involved in an at-fault traffic crash when she went through a steady red light westbound on Broad St. E. and stuck the driver's side of another vehicle that had a green light and was southbound on Central Ave. N. The defendant had watery, droopy eyes, slurred speech and a strong odor of an alcoholic beverage emitting from her breath. The driver of the vehicle that was struck identified the defendant as the driver to Ofc. Sloggett when he arrived on scene. Post Miranda, the defendant admitted running the red light and striking the other vehicle, and admitted consuming alcoholic beverages before driving. The defendant swayed while standing unsupported and when administered the HGN showed 6 point Nystagmus. The defendant refused to perform additional SFST's and was arrested for DUI w/property damage. Defendant was transported to CBT where she was administered a breath test. Defendant's BrAC measured .197 / .212. This occurred in Hillsborough County, Florida.
