The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did I observed the defendant driving a gray Honda with FL tag PJCC49 on the roadway. She passed me at over 40 miles per hour in a 30 mile per hour zone. I got behind her and she sped up to 50 miles per hour when the speed limit changed to 40. She continued speeding up to approximately 52 miles per hour and made a fast wide turn onto W. Green St from N. Howard Ave. I activated my emergency lights and conducted a traffic stop. I made contact with the defendant who was the driver and only occupant of the vehicle. I could smell the odor of alcoholic beverages from her breath. Her eyes were glassy and bloodshot. She admitted to drinking 3 drinks. She performed field sobriety exercises and showed impairment. Her breath alcohol content was .163 / .153.
