Pesta arrived on scene shortly after, demanding that police remove F. Peters from M. Peter's custody. Pesta provided court paperwork discussing the child custody agreement. Pesta was informed of the civil nature of the issue and that Police would not remove a child from a parent. I informed Pesta that I would document the incident and she would receive a case number to take to court.

Pesta began to get belligerent; as she was yelling and screaming at officers to get her daughter, causing a public disturbance. Pesta stated numerous times that she was going to retrieve her daughter herself, and officers on scene advised her against it. Pesta continued to yell and would not let officers explain how the situation was going to be handled.
