The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a light blue 2012 Nissan Altima, 4 door, Virginia tag UVS1087. The defendant followed my patrol car too closely, and would not create distance despite the tapping of my patrol car brakes, and she got closer to follow my vehicle through a yellow light at an intersection. The defendant made a turn without using a turn signal with other traffic present, drove over painted lane markers, and made a right turn from the wrong lane rather than using the designated right turn lane. A traffic stop was conducted. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed. The defendant initially stated that she drank one margarita with dinner, and post arrest spontaneously stated she drank two margaritas. The defendant was forgetful as related to the documents she had been requested to present. The defendant swayed mildly while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had a moderate degree of difficulty in following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant provided breath samples of .104% BrAC and .106% BrAC. The defendant was positively identified by her Virginia DL.
