The Defendant (863-698-0418) made contact with an undercover deputy via text after responding to a fictitious advertisement that was posted on a prostitution website. Through text and calls, the Defendant arranged to meet with the undercover who was posing as a prostitute for the exchange of \$60.00 in US currency for vaginal sex (with a condom). During text, the Defendant additionally asked the undercover if she was law enforcement. The Defendant was then directed to the hotel room which we were utilizing during the investigation. Upon contact with the undercover, the Defendant appeared to immediately become suspicious of the undercover and after a brief casual conversation, he walked out of the hotel room. The Defendant unlawfully made an appointment/engagement (Assignment) for prostitution and departed from the location in his registered Ford pickup bearing FL #IBNK21. A traffic stop was then conducted on the Defendant at the listed arrest location. I then called 863-698-0418 at which time the Defendant's phone rang and displayed my number.
