On 12/11/2020 at approximately 0010 hours, Corporal Garry M. Elser ABN: 229505 conducted a traffic stop at Dana Shores Dr / Rocky Shores Dr on a silver Mercedes Benz bearing Florida Tag: 8462VD. The reason for the stop was for driving with the headlights off (careless driving). Corporal Garry M. Elser contacted the driver, Schyler Colton Miles, who was in total control of the vehicle mentioned- above. Corporal Garry M. Elser noticed signs of impairment and requested a DUI-Investigator for a possible impaired driver. I contacted Schyler Colton Miles, who was standing on the rear driver's side passenger area. I conducted a welfare check on Schyler Colton Miles, who refused EMS.

I noticed signs of impairment on Schyler Colton Miles, such as slurred speech, red glassy eyes, unbalance on his feet, and a strong odor of alcoholic beverage on his breath. Schyler Colton Miles agreed to perform the Standardized Field Sobriety Exercise (SFSE's). Schyler Colton Miles failed to perform the SFSE's as instructed and demonstrated; see the AXON Body Cam Footage and RoadSide Video.

Due to the totality of circumstances and multiple signs of impairment observed on Schyler Colton Miles, I placed him under DUI arrest. I transported Schyler Colton Miles to the HCSO Central Breath Testing Section (CBT). After the mandatory uninterrupted twenty-minute observation period ended, Schyler Colton Miles provided two lawful breath samples. Schyler Colton Miles' breath BAC result reflected .161 / .145 (AE94OLE). Schyler Colton Miles identified himself via his valid Florida DL: M420-783-94-148-0.
