Leo advised over the radio that he had been flagged down by a black male in a white SUV who alleged that he had been shot at by another individual driving a silver/gray Chevy Cruze that was getting onto the Interstate. Sgt. Leo was able to intercept the silver/gray Chevy Cruze in the area of Interstate 95 southbound and Hypoluxo Road and conducted a traffic stop on the vehicle which was a 2011 Chevy Cruze with an attached New York tag of JBX6723. The driver was later identified by his Florida drivers license as Scott Michael Jensen (FL DL: J525793791080). Sgt. Leo advised that he smelled the strong odor of an unknown alcoholic beverage coming from the breath of Mr. Jensen as he spoke and he showed signs of alcohol intoxication. He was detained and placed in handcuffs by Sgt. Leo. Mr. Jensen admitted to Sgt. Leo that he did fire his firearm. The Lantana Police Department arrived a short time later and conducted a separate investigation in reference to the shooting (Case #: 20-000957). We left a short time later after being advised that the Lantana Police Department would take care of the entire incident. Later myself and Recruit Trooper Tomas were advised by Sgt. Leo that the Lantana Police Department was requesting our assistance in reference to the DUI portion of the investigation. We then traveled to the Costco parking lot at 1873 Lantana Road, Lake Worth, FL 33461 where the alleged shooting incident had occurred. Mr. Jensen was later brought to this location by the Lantana Police Department and we began the DUI portion of the investigation speaking to him in front of our marked patrol vehicle. Recruit Trooper Tomas read Mr. Jensen his Miranda Rights from a Florida Highway Patrol Miranda Warning card. Mr. Jensen stated that he understood his rights and he refused to answer any questions. As we spoke to Mr. Jensen we smelled the strong odor of an unknown alcoholic beverage coming from his breath as he spoke to us. His eyes were also red and glassy and at times he appeared to be unsteady on his feet. We asked him multiple times if he was willing to perform standardized field sobriety exercises and he would not agree to perform them. He was then given a Taylor warning and advised that his refusal to perform the exercises could be used against him and there could be adverse consequences. At one point without being prompted to Mr. Jensen attempted to walk heel to toe and he appeared to be unsteady on his feet failing to walk heel to toe on multiple steps. He refused to perform the field sobriety exercises. Once this was apparent we turned over Mr. Jensen to the Lantana Police Department for the shooting investigation. After the

Lantana Police Department had concluded their investigation they returned custody of Mr. Jensen to us. Based upon the above information and the totality of the circumstances I determined that there was probable cause to believe that Scott Michael Jensen committed the offense of driving under the influence by being in actual physical control/operating a motor vehicle while under the influence of alcoholic beverages, any chemical substance per Florida State Statute 877.111, or any controlled substance per Chapter 893, while their normal faculties were impaired. He was placed in the backseat of our marked patrol vehicle and transported to the Palm Beach County Breath Alcohol Testing (BAT) Facility. At the BAT facility a 20 minute observation period was conducted where the subject did not ingest anything by mouth or regurgitate (mouth was confirmed to be empty prior to the beginning of the observation period). He was then asked to provide a breath test sample to test for the alcoholic content of his breath. He initially refused to provide an affirmative yes or no response. He was then read the Florida Implied Consent drivers license suspension warning and he then agreed to provide a breath test sample. He provided a first breath test sample of 0.116 and a second breath test sample of 0.108. The Constitutional Warning document was then read and Mr. Jensen stated that he understood his rights and did not wish to answer any questions. He was then placed in a holding cell and the handcuffs were removed. After I finished my rough arrest report he was taken from the holding cell and handcuffed behind his back again. He was subsequently booked without incident. He was issued a DUI citation. All of the above events occurred in Palm Beach County, FL.

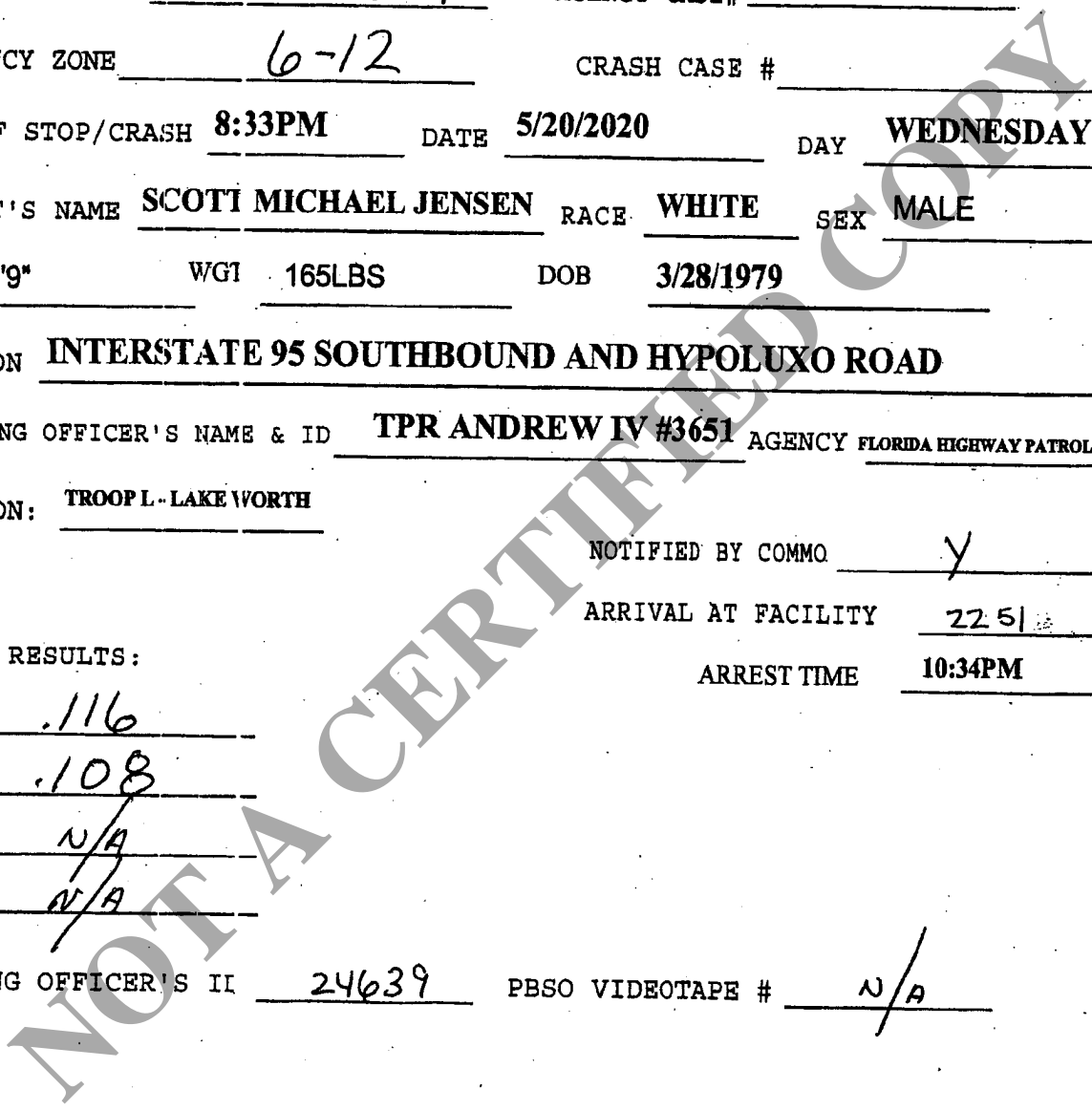
