Before me this date personally appeared COLANTUNO, MICHAEL (11734) who being first duly sworn deposes and says that on 12 day of February, (year) 2017 at 900 E COMMERCIAL BLVD, OAKLAND PARK, FL 33334 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On 2/12/2017, while in the area of the 900 Block of East Commercial Blvd., suspect Scott Moore did intentionally and unlawfully threaten by word and act to do violence to the person(s) of [REDACTED] and [REDACTED], coupled with an apparent ability to do so, as he pointed a black semi automatic firearm at the victims while yelling racial slurs which created a well-founded fear in victim [REDACTED] and [REDACTED] that such violence was imminent and further did commit the Assault with a firearm, a deadly weapon,

Before me this date personally appeared COLANTUNO, MICHAEL (11734) who being first duly sworn deposes and says that on 12 day of February, (year) 2017 at 900 E COMMERCIAL BLVD, OAKLAND PARK, FL 33334 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:
contrary to Florida Statute 784.021 (1) (a).

On 2/12/17, while victim [REDACTED] and [REDACTED] were driving in their blue Kia vehicle, they approached a median on East Commercial Blvd. As [REDACTED] the passenger and [REDACTED] the driver attempted to make a U turn, a vehicle heading east on Commercial Blvd almost crashed into them. The driver of that vehicle which was in a white Nissan drove to the passenger side of [REDACTED] and [REDACTED]'s vehicle and pointed a black semi automatic handgun at them and threatened to do harm to them. The same suspect yelled racial slurs at them as both vehicles sped off. The victims drove to a nearby gas station to call 911 and report the incident. While they were on the phone reporting the incident, the suspect drove in the same parking lot and again pointed his firearm at them while once again yelling racial slurs toward both victims. The victims wrote down the tag, make/model and the color of the suspect's vehicle. A check of the available police databases showed that the vehicle driven by the suspect was registered to w/m Scott Moore.

On 3/20/17, I was able to meet and interview victim [REDACTED] regarding the incident. He explained to me that the suspect was within 5 feet from him while the suspect pointed the firearm at him thus causing [REDACTED] to be in fear for his safety. [REDACTED] told me that he saw the firearm being pointed at him two separate times from the driver of the white vehicle. In a Double Blind photo lineup, [REDACTED] picked out suspect Scott Moore as the suspect that committed the mentioned offense.

It should be noted that victim [REDACTED] has not returned my phone calls or responded to a BSO No Contact Letter to his home requesting that he speak with me regarding this investigation.
