The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 04/25/2020, at approximately 2319 hours, I responded to 1st St SW. and 14th Av SE. Ruskin, Fl. 33570 to assist Deputy Sweder(ABN:254510) with a traffic stop. Deputy Sweder explained he conducted the traffic stop due to observing the vehicle drive off the roadway and back on to the roadway. Deputy Sweder then conducted a welfare check on the defendant and observed indicators of impairment. When I made contact with the defendant, I observed the defendant to have watery/glassy eyes, odor of an alcoholic beverage emitting from his breath, and a freshly lit cigarette in his hands. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide a lawful breath sample after implied consent was read. The defendant was identified via Florida Driver's License.
